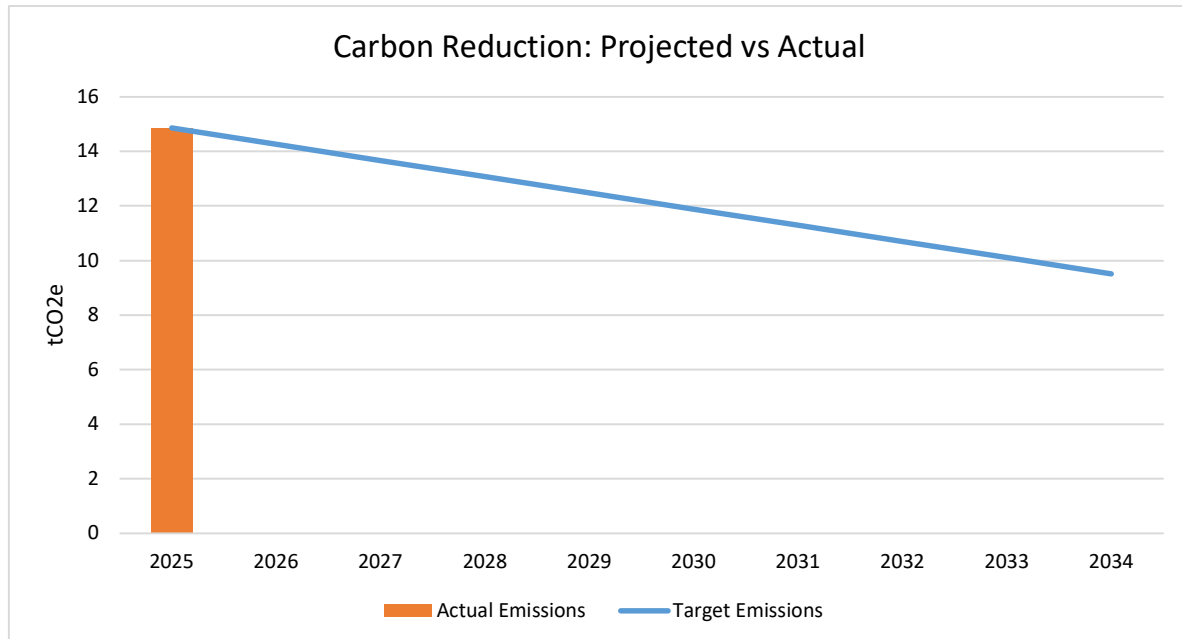

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 11.9 tCO₂e by 2030. This is a reduction of 20 %

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2025 baseline and the measures will be in effect when performing the contract.

- Reduced commuting emissions by encouraging staff to walk to work
- Changed non LED lighting to LED

Future Carbon Reduction Initiatives

In the future we hope to implement further measures such as:

- Update the procurement process to ask suppliers if they have a Carbon Reduction Plan
- All staff to receive CPD training on carbon reduction in the next 12 months
- Buy consumables locally rather than ordering them to be delivered
